

# **Laramie Plains Civic Center Ghost Sign Temporary Artwork**

# REQUEST FOR QUALIFICATIONS

Deadline: November 29, 2023 at 5 PM MT

Artist design fee: \$1,000

#### **OVERVIEW**

Laramie Public Art Coalition (LPAC) and the Laramie Plains Civic Center (LPCC) are teaming up to art up an abandoned sign on the 7th Street side of LPCC. An artist will be selected to create an artwork that will be printed on mesh vinyl banners, 3 feet by 6 feet, to hang within the empty frame.

The desired artwork will be colorful and communicate a message of love for the community in line with the LPCC mission and vision:

- Mission: community fostering connections, nurturing creativity, and ensuring an enriched future.
- Vision: cultivate a vibrant and inclusive space for people to gather, connect, and grow.

As the artwork will be printed onto mesh vinyl, the colors will be muted slightly, which the artist should take into consideration in the design. Artwork can be digitally created or have the ability to be digitally reproduced. LPAC will pay for the installation and fabrication.

The banners will be temporary and installed from January to June 2024. Upon deinstallation, depending on condition, banners will be auctioned to support continued programming. Artist would receive a percentage of auction proceeds.

#### **ELIGIBILITY**

The call is open to all artists ages 18 and over, regardless of race, color, religion, national origin, gender identification, age, military status, sexual orientation, marital status, or physical or mental cognition. Artists must live in Laramie, Wyoming.

#### BUDGET

\$1,000 artist design fee. LPAC will cover installation and fabrication costs.

#### **SELECTION PROCESS**

A selection committee including LPCC stakeholders and residents will select the artist to create the banner designs. The committee will be looking for an artist with experience creating vibrant artwork in any medium.

#### **SCHEDULE**

• RFQ released: 11/2/2023

Submission deadline: 11/29/2023 at 5 PM MT

• Artist selected by 12/4/2023

Artwork design review will be conducted by the selection committee in late December. Installation schedule to be determined by the Artist and LPAC. Installation to happen in January 2024.

#### **APPLICATION REQUIREMENTS**

#### RFQ Materials shall include:

- 1. Statement of interest: Indicate why celebrating love for the Laramie community would fit within your artistic practice. Please include name, phone number, email and address at the top of the statement. (Limit to 200 words)
- 2. Media: 5 digital images of relevant completed artwork. Artist(s) may submit up to two videos of relevant artwork, if it is essential to understanding the work. Label images/media: last name of artist, artwork title, installation date. JPGs only.
- 3. Media script: Short description of each completed artwork submitted as media. The media script should include the budget of the project, the location, and the artwork intent. (Limit to 100 words per artwork).
